## Restricted License for Farm Work

- This information is collected by authority of [Minnesota Statutes section 171.041](#).
- A property tax statement showing that the address of the farm the minor is working on is listed as agricultural land is required for all applications.
- If a parent/guardian is renting land classified as agricultural land, a rental statement or agreement must also accompany the property tax statement.
- If a minor is working on land classified as agricultural land, not owned or rented by the parent or guardian, this form must also be signed by the farm owner, which must match the name on the property tax statement.

- I understand the purpose of this form is to allow the minor listed above to be issued a restricted farm work license.

- I understand the minor may only drive alone and only operate a motor vehicle during daylight hours within a 40-mile radius of the farmhouse where the minor is working, and that a violation of these restrictions may result in the suspension or revocation of the minor's driving privileges.
- The minor is not required to comply with the six-month instruction permit possession provision or with the twelve-month provisional license provision.

## **Tennessen Notice:**

### **What is the purpose of supplying additional information?**

Driver and Vehicle Services (DVS) collects the requested information for identification purposes to issue a minor a restricted license for farm work, as required by Minnesota Statutes, section 171.041.

### **Am I required to provide this information?**

No. You are not required to provide this information.

### **What will happen if I do not provide this information?**

You can refuse; however, DVS will consider the application incomplete and cannot issue a minor a restricted license for farm work because they will not be eligible.

### **Who will have access to the requested information?**

DVS may disclose personal information when it relates to the operation or use of a vehicle or to public safety. The use of personal information relates to public safety if it concerns the physical safety or security of drivers, vehicles, pedestrians or property. The personal information provided for the applicant to obtain a restricted license for farm work is classified by 18 United States Code, section 2721, Minnesota Statutes, section 171.12, and the Minnesota Government Data Practices Act, Minnesota Statutes, Chapter 13, and is subject to the disclosure in accordance with these laws.
