**If you have religious objections to complying with driver's license and identification card image requirements, you may petition in writing for a variance.**

- Mail form with nonrefundable \$10 fee to: Driver and Vehicle Services, DVS Variance Request, 445 Minnesota Street, St. Paul, MN 55101-5183. Checks or money orders are payable to Driver and Vehicle Services. **Please do not send cash.**
- Additional information may be required before granting or denying this petition. You will be notified of the Department's decision by mail within 30 days of receiving your petition.
- If you are approved for a variance, you will need to bring actual, original documents with you when you apply in person at a driver's license office.
- All information requested on this form is required by Minnesota Statutes, sections 14.055 and 14.056, or Minnesota Rules, part 7410.1810. *If incomplete, your petition will be automatically denied.*
